## Code Enforcement

Our June guest speaker will be **Loren Due** from the Code Enforcement office of the City of San Jose. Lauren is our local enforcement officer and can answer questions about the previous driveway sweep actions, pending amendments to code enforcement laws and other questions you may have.

We know there were many questions at our last meeting concerning new code enforcement amendments, so please bring your questions that weren't answered before to this meeting.

Code Enforcement is a department that is complaint driven. If you call to complain they will come out, but they don't necessarily go out looking for code violations. They can't act on violations if they don't know they exist. An example recently is a residential swimming pool that wasn't cleaned in a long time, presenting a health hazard. Without a neighbor's call they wouldn't know the problem existed.

Cards will be available for you before the meeting. We ask that you write down your specific questions prior to the meeting. This will give our speaker a chance to organize the questions and maybe answer them in his presentation. You don't need to give your name, but please ask specific questions.

## Neighborhood Clean Up

A committee has been formed to organize a SONA-wide clean up and dumpster day. Charles Crowder has applied for a CAP grant and other funds may be available from a NAC (Neighborhood Action Committee) CAP grant.

No date has been set yet, but volunteers are needed. We need people to supervise the dumpsters themselves to make sure they don't get over filled, help move items from homes or yards where the owner or tenant is not able to physically move the items and we'll also need volunteers to help organize the post-dump party. (And I wouldn't mind somebody coming up with a catchier phrase than dumpster party.)

During the hustle and bustle, Sonya found herself in a conversation with a gentleman who was enquiring about the studio for rent. Seems he'd seen the signs pointing to the "studio". No word on whether or not he became a fan of Sonya's art.

And which neighbors were doing a good deed only to find themselves answering to the police? Seems that a couple of our neighbors have taken advantage of the City's anti-graffiti group and have paint at the ready to cover up gang tagging. Much to their surprise, they found themselves lit up by a spotlight from a local police patrol. It all ended well and I'm guessing that the police were just as surprised as our thoughtful neighbors.

## Strong Neighborhoods Initiative

The Strong Neighborhoods Initiative (SNI) is a project designed to bring services and amenities into the neighborhoods using Redevelopment Agency (RDA) funds

The SNI project covers neighborhoods across the city. They have been broken down into 20 different Neighborhood Action Committee (NAC) areas. Each NAC is made up of interested people from the NAC project area and includes neighborhood groups, service groups and other interested parties. About half of the Sherman Oak Neighborhood Association is in the Burbank/Del Monte NAC.

The NAC comes together for long-term planning to determine what would make that project area a better place to live. The NAC then designs specific projects in the area and prioritizes them. The Burbank/Del Monte NAC plan has been approved.

The Project Action Committee (PAC) is the organizing group for all of the NACs. It will be the PAC who determines policy and funding recommendations

Of the 20 NACs, about 1/2 have submitted their plan to City Council and have been approved. The PAC goes before the Council on 6/11/02 for approval.

The Burbank/Del Monte NAC has identified the top 11 priorities in the NAC. A sign up sheet will be available for you at the June 13 SONA general meeting if you are interested on being on one of these committees.

- Completion of the Buena Vista Tot Lot on Scott and Menker. The lot is owned by the City, but there is no funding available to build the Tot Lot.
- Designate Scott St. and Auzerais as a primary Pedestrian/Bikeway. This will allow upgrading of sidewalks and complete streetscaping.
- Conduct a feasibility study for a freeway overpass park in front of City College. This is a way of capturing air space to provide the area with a large park.
- Work with San Jose City College to build a 17,000 sq ft multi-use recreation center (already underway).
- Conduct a programs/services inventory and needs assessments survey to determine what services are needed and what facilities are available.
- Initiate a regular bulky waste pick up day (some funding already secured).
- Strengthen Code Enforcement and Housing Programs.
- Create an economic development strategy for West San Carlos Street and Bascom Avenue

- Establish a trolley service along West San Carlos Street and Bascom Avenue. This would also have the potential for running in front of San Jose Medical Center and San Jose City College, linking the area to the Diridon Station and downtown.
- Develop a new public neighborhood park along Los Gatos Creek at Auzerais Avenue. This would also facilitate linking of the creek trails.
- Implement strategies to address any adverse impacts related to adult business activity on Burbank/Del Monte neighborhoods (already under way).
